## ADULT CLASS REQUIREMENTS:

• **Open Male/Female:** for all Rottweilers 24 months and older without a USRC recognized breed test, Championship or USRC Sieger/Siegerin title.

• Champion Male/Female: for all Rottweilers 24 months and older who have earned a Championship. This includes AKC and CKC Champions, International FCI Champions and any champion of record from a country whose Championship was awarded by an FCI recognized kennel club. Those dogs entering the Champion class who are eligible to be awarded the USRC Sieger/Siegerin title must be USRC registered.

• Working Class Male/Female: for all Rottweilers 24 months and older with a USRC recognized Schutzhund or IPO title and breed test, who have not earned a USRC Sieger/Siegerin title. The dog must be USRC registered..

• Sieger/Siegerin Class: for all Rottweilers 24 months and older who have earned a Sieger/Siegerin title from a USRC Nationals or Regional Show or have been awarded the USRC Universal Sieger/Siegerin title. Dogs eligible to enter the USRC Sieger or Siegerin class may not enter the Open, Champion or Working class; however, the dog may enter the Veteran class if age permits.

• Veteran Male/Female: for all Rottweilers 7 years or older on the day of the show. Those dogs entering the Veteran class will not receive a rating but will be eligible for the Select award.

### NON-REGULAR CLASS REQUIREMENTS:

•Kennel Group: entered by the kennel owner. Three (3) or more dogs bred by the kennel owner and registered with the kennel name of the entrant. The kennel owner need not be the registered owner of the dogs. All dogs must first be registered in the show's regular classes. Written critiques are not given.

• **Brood Bitch:** entered by the owner of the brood bitch. The brood bitch and at least two (2) of her offspring must appear in the ring. The bitch must have a USRC recognized breed test and have been at least 24 months of age at the time of breeding. The class is to be evaluated on the merits of the offspring. The owner of the brood bitch need not be the owner of the offspring. The offspring must first be entered in the show's regular classes. Written critiques are not given.

• **Stud Dog:** entered by the owner of the stud dog. The stud dog and at least two (2) of his offspring must appear in the ring. The dog must have a USRC recognized breed test and have been at least 24 months of age at the time of breeding. The class is to be evaluated on the merits of the offspring. The owner of the stud dog need not be the owner of the offspring. The offspring must first be entered in the show's regular classes. Written critiques are not given.

## Code of conduct

All participants of this, and any show presented by SMWRK will be expected to behave in an adult and sportsmanlike manner at all times while on the show grounds. Behavior not acceptable to the club will be dealt with in a timely manner and involved persons may be disqualified from the show and asked to leave the grounds.

# **Class Entry Rules**

Once a dog is eligible for the Champion, Working or Sieger/Siegerin class the dog may not enter the Open class. When a dog is eligible for more than one class, the dog's owner determines the entry. If a dog is eligible for the Sieger/Siegerin class the dog may not be entered in any other class.

### **Additional Entry Information:**

• Photocopies of support documents for all titles and accomplishments MUST be sent in with the entry, original documents must be available for inspection at the show.

• Effective January 1, 2006, all dogs entered in USRC sanctioned events who are 30 months of age and older must possess a USRC recognized hip certification, whether pass or fail, which will be indicated in the event catalog. Dogs that do not meet these requirements will not be permitted to enter.

• No dogs shall be permitted to enter any class with missing teeth. Dogs entered that are found to have missing teeth will be dismissed from the ring and will not be critiqued.

• Dogs born after 6/1/1999 in countries with anti-docking laws must be shown with a natural tail.

• Dogs are shown in a natural stance, no hand stacking allowed. Double handling is permitted.

• Dogs must be baited from outside the ring. Absolutely no food is allowed in the ring or for baiting purposes.

• Adult classes will be moved (run) long enough for the judge to evaluate the dog's movement and fitness.

• At no time will handlers, owners or spectators interfere with the judge or otherwise hinder their ability to assess the dogs being presented to them in the ring. This includes the final baiting phase. One warning will be issued. If a second instance occurs, the offender will be asked to leave the ring area regardless if they are showing a dog entered in the class and will forfeit any entry fees.

• The decision of the judge or Kormeister is final.

Trophies for 1st-4<sup>th</sup> place will be awarded as each regular class concludes. Only 1<sup>st</sup> place will receive a trophy in Kennel, Brood and Stud classed.

LUNCH BREAK will be at the judge's discretion each day.

### BST Prerequisites and Information for Owners/Handlers of Dogs Entering a BST

1. The judgment of the Kormeister or Judge is final. No appeals are possible.

2. BST critiques are not official until checked, recorded and signed by the Head Breed Warden and/or the Administrator of Records. After the BSTs are approved, the original copy will be forwarded to the dog owner. The BST paperwork must be complete and available for inspection on the day of the test. If this is not done, the BST will not be signed and will be deemed invalid. The dog may retest.

3. Both the owner and handler must be USRC members.

4. The owner and/or handler of any dog are liable for any damage caused by his or her dog.

5. The dog must be registered with USRC.

6. The dog must be tattooed. A microchip will be allowed in lieu of a tattoo provided the handler supplies a working scanner.

7. The dog must have a USRC recognized hip certification.

8. The dog must have passed the Schutzhund BH.

9. The entry form for the BST must be sent to the Host Club before the entry closing date.

10. Copies of the following documents must be submitted with entry:

a. Copy of USRC Membership Card for both owner and handler.

b. Copy of USRC Registration for the dog being entered.

c. Copy of Scorebook showing titles earned, scorebook number and full name of dog. If the BH is earned after the close of entries a copy of the scorebook showing the BH title must be presented to the BST secretary on the day of the Breed Test.

d. Copy of USRC recognized Hip Certification.

e. Weight certificate (if requested by the host club) dated within 30 days of the test date. f. The USRC Registration Certificate may be accepted as proof of titles earned and hip certification if the required information appears on the Registration Certificate.

11. The following **Original** documents must be submitted to the BST Secretary on the day of the Breed Test. Entry into the BST will not be accepted without presenting these originals prior to taking the test.

a. USRC Membership Card for both owner and handler. A copy of the membership card will be accepted on the day of the show. This exception to the original document requirements applies to the membership cards only.

b. USRC Registration for the dog being entered.

c. Scorebook showing titles earned (minimum of BH) scorebook number and full name of dog.

d. USRC recognized Hip Certification

e. Weight certificate (if requested by the host club) dated within 30 days of the test date. f. Prior BST attempts.

g. The USRC Registration Certificate may be accepted as proof of titles earned and hip certification if the required information appears on the Registration Certificate.
