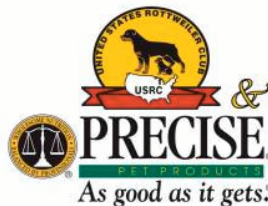

Dogs born in countries where docking is forbidden by law, shall be shown with the tail left in its natural state. If a dog is presented at the BST and a tail, which has been cut in violation of these rules, the dog shall not be allowed to participate.

BREED SUITABILITY TEST

The BST is designed to select those Rottweilers that are worthy of being bred. The dog's conformation must be judged of breeding quality and free of disqualifying faults. The dog must have a valid OFA or GDC number or ADRK rating of HD- or HD+/- and have a tattoo for identification. Once the conformation and soundness qualifications have been met, the dog's temperament is tested. This test includes a gun sureness test, a protection test, and a test to ensure that the dog is stable around the public. The USRC strongly believes that these tests are vital to maintain the Rottweiler in type and temperament.

BST REQUIREMENTS

1. Owner and handler must be members of the USRC.
2. Dog must be registered with the USRC.
3. Dog must have a tattoo or microchip. If microchipped the handler must supply a working scanner for the chip to be read. If chip cannot be read the BST will not continue. Entry fee will not be refunded.
4. Dog must have a BH title.
5. Dog must have a weight certificate from a vet within the past 30 days.
6. Dog must have a USRC recognized hip certification.

BST PROCEDURE

1. Dog will be measured and must show correct dentition.
2. Dog must walk on loose lead through a crowd of people.
3. Two gunshots will be fired from 15 to 20 feet away to note the dog's reaction.
4. Attack on handler.
5. Courage test.

OWNER MUST BRING TO THE TEST

1. Original USRC Registration Certificate.
2. Original OFA or GDC (if not shown on USRC registration certificate)
3. Official USRC, USA, or DVG scorebook with BH title marked as passed.(if not shown on USRC registration certificate.)
4. Original USRC membership cards of owner and handler.
5. Weight certificate signed by a vet within the past 30 days.
6. Paper work of prior BST attempts.
