## Sport Medal Application

All information must be typed or printed neatly

(One Form per Dog or Medal)

### Sport Medal Qualifying Information:

1. The owner must be a member in good standing with the USRC when applying for the award.
2. Any USRC/USA/DVG/FCI sanctioned trial is valid for points earned.
3. Scores from OB1-3, TR1-3, StP1-3, RH1-3, SchH/IPO/AWD1 and 2 can only be used once.
4. Scores obtained from SchH/IPO/AWD3 or FH1-2 can be repeated.
5. Scores obtained at Regional or National trials earn one (1) extra point.
6. The dogs must have been trained and handled by the applicant to earn points.
6. Sport Medals are awarded to the handler

Please see rulebook for additional rules regarding previously owned dogs, dogs older than 6yrs and other qualifying titles.
