## Scorebook Order Form

All information must be typed or printed neatly

**Official Scorebooks are required for entry to all USRC Sanctioned Schutzhund Trials.** There is a charge of \$10.00 for a USRC scorebook. There will be a \$25 RUSH FEE added to scorebooks ordred within 10 business days of trial. One scorebook is required for each dog, and the scorebook must be transferred with the dog when sold.

- To receive a scorebook, application must be made to the USRC Administrator of Records and must include the following:
1. A photocopy of your current USRC membership card\*. (\*Allow 2 extra weeks if also applying for USRC membership)
  2. A photocopy of your dog's registration certificate.
  3. If available, a photo copy of your dog's hip certification and AKC or USRC certified pedigree.
  4. If the dog has been ADRK or USRC tattooed, include tattoo number.
  5. If the dog has already achieved a Schutzhund title, including FH, AD, etc., under a VDH recognized judge, send proof of each title with the application.
  6. Please circle USRC or AWDF (see below) below to denote which scorebook is being applied for. If not noted, a USRC scorebook will be issued.

If this scorebook is lost or destroyed, it may be replaced by notifying the Administrator of Records, and a replacement fee of \$10.00 is paid.

**NOTE:** Handlers with USRC scorebooks who wish to enter a USA trial must have their scorebooks certified by USA. There is no charge if you are a current member of USA. If you are not a member, there is a fee for scorebook certification by USA. Send to: USA, 3810 Paule Avenue, St Louis, MO 63125
