## Merit Award Application

All information must be typed or printed neatly

(One form per Dog/Award)

### Bronze Merit Award Qualifying Information:

The owner must be a member in good standing with the USRC when applying for the award.

The dog receives a **USRC BST\*** and a **V Rating\*** at a USRC Sanctioned Show.

The dog must be registered with USRC when the V Rating and the BST are obtained.

### Silver Merit Award Qualifying Information:

The owner must be a member in good standing with the USRC when applying for the award.

The dog receives a **USRC BST\***, a **V Rating\*** at a USRC Sanctioned Show and a **SchH or IPO title\***.

The dog must be registered with USRC when the SchH or IPO title, V Rating and the BST are obtained. (titles may be repeated to qualify)

### Gold Merit Award Qualifying Information:

The owner must be a member in good standing with the USRC when applying for the award.

1. The dog receives a **USRC Breed Test\*** (BST, ABST, LBST).

2. **Three V ratings\*** at USRC Sanctioned Shows under two different judges, one V rating must be obtained at a USRC Regional or National Sieger Show

3. A **qualifying SchH or IPO Score\***. Females must have a SchH/IPO1 270, pronounced. Males must have a SchH/IPO3 or 270 pronounced.

The dog must be registered with USRC when the qualifying SchH score, V Rating and the Breed Test are obtained. (titles may be repeated to qualify)

**\*To receive a USRC Merit award, the owner must submit copies of the dog's qualifying achievements and a completed USRC Merit Award form to the Administrator of Records.**
